

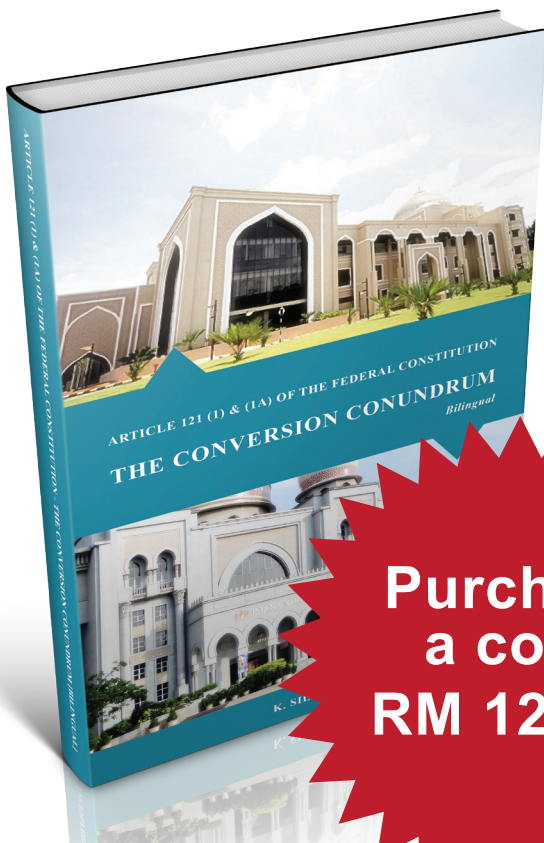
THE CONVERSION CONUNDRUM
